Code of Conduct

Hygiene

Facilities will be provided for you on all ConstructWell sites. It is your responsibility to ensure that you follow the basic rules for health and hygiene as failure to do this can cause sickness and ill health to you and your fellow workmates.

Keep these areas and other facilities clean. Place all rubbish, particularly food scraps, in the bins provided.

Housekeeping

Good housekeeping is mandatory; every worker must do their part daily to keep the job safe, efficient and clean.

- Keep materials stacked in designated areas.
- Keep tools and equipment is areas free from passageways and exits.
- Keep stairways, landings and access ways clear at all times.
- Keep work areas clear of trip and slip hazards.
- Wipe up oil or grease as soon as it is spilled.
- Cover or protect projections or protruding objects.
- Ensure all electrical leads are appropriately fixed and clear from walkways.

Working at Heights

ConstructWell is committed to a planned approach in eliminating or minimising potential fall hazards. All persons must be protected against falling. Similarly, persons below must be protected from potential falling objects and material.

Where it is not practicable to provide scaffolding or guard rails due to the nature of the work, appropriate working at height systems must be used. Workers must be fully instructed and trained in the use of safety harnesses, approved attachments and insure relevant regulations or codes of practice and manufacturer's recommendations are enforced.

Falling objects are a serious hazard on construction sites. Where workers or other persons are likely to be exposed adequate overhead protection must be enforced.

Asbestos Management

Prior to commencing work on site ConstructWell will have identified any asbestos and put in place controls to reduce the risk of exposure of the hazardous substance. This includes removal by licensed asbestos removalists, signage, barriers etc.

If you suspect an area contains asbestos you must stop work immediately and report to the onsite supervisor.

Working in Isolation

If there is a requirement for a contractor to conduct any work related activity in a remote or isolated area. A Safe Work Method Statement will need to be completed and by ConstructWell prior to work commencing.

Accident / Incident Report

All workplace injury or illness, however small, must be reported immediately to the site supervisor and ConstructWell Accident /Incident Report Form must be completed within 24hrs.

Hazardous Substances/ SDS

Many substances which are used in everyday life or on construction sites have the potential to be hazardous if procedures for safe use are not carefully followed. Instructions regarding precautions to be taken for the safe use, handling, storage etc. of potentially hazardous substances will be supplied by your employer who will obtain current copies of relevant safety data sheets (SDS) from manufacturers, suppliers etc.

Flammable liquids e.g. Petrol must be stored in well ventilated areas, in approved metal containers and be suitably labelled.

Disciplinary Action

Disciplinary action will apply to safety breaches including breaches of the rules contained in this booklet, not complying with Safe Work Methods or Legislative requirements

Disciplinary action can range from re-induction, retraining, counselling and / or suspension from site. For serious and repeat breaches, the disciplinary action can include immediate permanent expulsion from the site.

Tool Box Talks

As a construction worker you are part of a team of skilled professional workers, and accident prevention is part of your job. This is a great opportunity to share valuable information regarding tasks for the day, week or as part of the whole project.

Plant and Equipment

In order to comply with Work Health & Safety Legislation, ConstructWell will carry out regular inspection and maintenance of plant and equipment. The inspection and maintenance of each item will be in accordance with the relevant standards and manufactures specification. The inspection and maintenance history of each item is documented and is available on request.

Personal Protective Equipment

The wearing of personal protective equipment (where it has been assessed as necessary) is mandatory for all workers, contractors, sub-contractors and visitors. Failure to wear the appropriate personal protective equipment will be seen as failure to obey reasonable instruction and disciplinary will be taken.

Eye Protection

Where is has been assessed as necessary eye protection must be worn for prescribed tasks including grinding, cutting and welding including but not limited to in certain situations may be deemed compulsory on some sites.

Safety Boots

As per Australian Standard footwear with protective toecaps must be worn by all personnel on site. In particular – be sure that your footwear has good tread and no exposed metal.

Hearing Protection

Approved hearing protection must be worn wherever high noise levels have been identified: e.g. work such as jack hammering, grinding, mitre saws, circular saws, belt sanders, hammer drills, use of explosive powered tools, or other impact tools or other equipment where there is a foreseeable risk of hearing damage.

Head Protection

Safety helmets must be worn by all personnel at all times whilst on site. Particular wherever a person could be struck by any falling material or other objects, and in all areas designated as hard hat areas.

Hand Protection

Suitable gloves are to be worn when handling any materials or substance which might cause harm to your hands, e.g. epoxies, paint, concrete, bricks, wire cables, steelwork. Some tasks increase the risk of hand injuries and the correct type of gloves should be provided. Avoid wearing when working with or near moving machinery.

High Visibility Vests

High Visibility Vests must be worn at all times on site.

Respiratory Protection

Appropriate respiratory protection must be worn in areas having excessive dust or other contaminants.

Correct selection, fit and use of personal protective equipment is critical to getting the best possible protection.

Should be remembered as per AS 1715 when using respirators the operator be insure that they are clean shaven.

UV Protection

Exposure to ultra-violet radiation poses a significant health hazard for outdoor workers.

If working outside all contractors must ensure appropriate PPE, SPF 30+ sunscreen is provided to ensure adequate sun protection.

Test and Tag

All portable and semi portable electrical equipment must be tested in accordance with Australian Standard 3760. Labels must be fixed to equipment showing date of inspection and equipment plant number.

Electrical power leads may only be used if they have been tested and tagged in accordance with Australian Standard and State regulatory requirement.

White Card

All contractors must have a valid Induction for Construction Work (White Card) prior to commencing work on ConstructWell sites.

Smoking

Smoking is not permitted at any ConstructWell sites. Designated areas will be allocated for smoking.

If you are present when a fellow worker is injured, provide assistance where possible or contact Emergency services as required.

First Aid Emergencies

In every emergency situation, you must first look for conditions that are an immediate threat to the casualty's life.

By following the Emergency Action Plan you can help save someone's life.

DRABC

(Danger - Response - Airway - Breathing - Circulation)

D Danger: Before rendering any aid, ensure that you are not placing yourself at risk of injury.

R Response: Speak loud and clear to the patient, if possible try to get a verbal response.

A Airway: ensure the patient has a clear airway.

B Breathing: ensure the patient is breathing, if not, commence Expired Air resuscitation (EAR)

C Circulation: Check pulse. If patient has no pulse and is **not** breathing, commence cardio-Pulmonary Resuscitation (CPR)

D Attach Defibrillator (AED) as soon as available and follow the prompts.

Comfort, reassure and monitor the patient until medical aid arrive
